ADOPTION CONTRACT

I, _____ agree to Adopt _____

ID # _____ described as _____ Male/Female Cat from

Cat Rangers ("CR"), a Georgia 501c3 nonprofit corporation. In connection with this adoption, and to protect the Cat's I agree to the following:

1. _____ The Cat's behaviors and habits known by CR have been discussed with me but CR makes no representations or warranties whatsoever regarding the Cat's condition or behavior. Any representations made regarding age, health, or personalities are based on the information available to CR. I hereby release CR from any and all loss, expense, damage or claim relating in any way to the Cat, CR's adoption of the Cat, and representations made relating in any way to the adoption of the Cat.
2. _____ I will be given a record of the Cat's medical history as known by CR. I understand that despite veterinary care, the Cat may have a previously undiagnosed condition. I understand that CR will not refund adoption fees for any reason but that I may return the Cat to CR at any time or keep the Cat and assume full responsibility for medical care of the Cat. This cat has the following known condition _____.
3. _____ I will provide care and attention to ensure the Cat's health and well-being, including (but not limited to) quality food, fresh water, playtime and INDOOR ONLY shelter, and all emergency and routine veterinary care. Routine veterinary care includes FVRCP & Rabies vaccines, flea, tick and heartworm preventative and a YEARLY physical exam.
4. _____ The Cat will be a personal pet and will be kept at the address listed on this contract. I will inform CR of any changes with 90 days of such change.
5. _____ I represent that I live on property where the Cat is allowed and that I have paid any and all associated fees for the Cat to live at the address stated on this contract.
6. _____ I agree to allow a CR representative to visit my residence at any reasonable time to ensure all terms of this contact are being met.
7. _____ I will NOT DECLAW this Cat. In the event this cat is declawed, I agree to pay CR the sum of \$1,000.00 as liquidation damages. This liquidated damage value is agreed to for the purpose

of establishing the base value of the Cat and does not bar CR from seeking return of the Cat by judicial process or other legal means. In addition, I agree to pay reasonable attorney fees and court costs in the event this matter is forwarded to court or to an attorney for enforcement.

8. _____ I understand that if my new pet is not old enough to be spayed/neutered before going home I will either bring him/her back for surgery at a CR vet or provide proof that s/n has been done elsewhere.
9. _____ I agree that if for any reason I cannot keep the Cat, it MUST BE RETURNED TO CR along with all medical records. The Cat may NOT BE SURRENDERED to any other rescue group, shelter or person at any time.
10. _____ I understand that noncompliance of any provision of this contract constitutes a breach and the Cat must be returned immediately upon demand to CR.
11. _____ I understand that I am adopting, not purchasing the Cat and the whole of the adoption agreement is contained within this contract.
12. _____ I am at least 18 years of age, have read this entire contract, and understand all of the terms contained in it.
13. _____ I understand that additional vaccines not covered by the adoption fee may be needed and I/we must take the cat and medical records to a vet for evaluation. (vaccines covered are as age appropriate at the time of adoption).
